This document will serve as a binding agreement between the Barrel Club Member(s) and Rosemont of Virginia, LLC (dba Rosemont Vineyards) in regards to the terms, privileges and rewards associated with being a Rosemont Vineyards Barrel Club Member.

In exchange for paying Rosemont Vineyards the sum of **One Thousand Dollars (\$1000.00)** plus appropriate sales taxes at the time of the signing of this agreement, the Barrel Club Member(s) are entitled to the following privileges and rewards from Rosemont Vineyards over a period of four (4) years from the date of Membership.

1. "Sponsorship" of one of Rosemont Vineyards' wine barrels. One of Rosemont Vineyards' wine barrels will be adorned with a handsome plate on which your name will be engraved. (Because of operational factors associated with aging wines in barrels, the barrel you sponsor may be different from year to year.) No later than 1 year after the termination of this agreement, you will receive one of Rosemont Vineyards wine barrels (empty of course), with your nameplate attached. The plate will also be engraved with the wines that had been aged in your barrel. The Barrel Club member is responsible for removal of the barrel from Rosemont Vineyards' premises.
2. One case of *Rosemont of Virginia* wines of your choosing per calendar year for four (4) consecutive years starting with the year in which the agreement is signed. A case consists of 12 bottles of any *Rosemont of Virginia* wines except those wines designated by Rosemont Vineyards as "Limited Production" wines. The Barrel Club member is responsible for picking up the wine at the Winery.
3. Free wine tastings at Rosemont Vineyards and Winery's tasting bar for the member and their spouse/companion/friend.
4. Free admission for the member and their spouse/companion/friend to any concerts and festivals sponsored solely by Rosemont Vineyards and held on its premise. Such events will be duly noted. (Wine tasting dinners are not included.)
5. Sixteen (16) free wine tasting passes for use by the member's friends. Each pass will entitle the recipient to taste all of *Rosemont of Virginia* wines that are available for tasting.

- 6. A fifteen (15) percent discount on all quantities of wine purchased at Rosemont Vineyards and Winery.
- 7. Each year for four consecutive years, the member(s) and four/five of their guests (six total), will have the opportunity to set up an appointment with Rosemont Vineyards' winemaker to do a wine barrel tasting. The members and their guests will taste out of a minimum of 5 barrels of wine, including the barrel that you are "sponsoring." Appointments need to be made at least 2 weeks in advance. (The winemaker has the right to not schedule tasting sessions during the harvest season (August 15 through October 15)). Barrel tastings normally last 45 to 60 minutes.

A membership in the Barrel Club is restricted to a maximum of two members (i.e. a member **or** a member and their spouse/companion/friend). If there are two members and you are friends, you must decide how the privileges and rewards will be divided. **Also only one member per year will be allowed the 15% discount on additional wine purchased (Item 6 above).** However, members can designate who will receive the 15% discount for each of the four years.

A signed copy of this agreement along with Attachment "A" will be kept at Rosemont Vineyards and Winery to document compliance with the requirement of this agreement.

It is understood that in no way does the terms of this agreement imply that the Barrel Club Member(s) are investing in Rosemont of Virginia, LLC or conveys ownership of any of Rosemont of Virginia, LLC 's products and/or assets.
